SUMMARY

Council has allocated \$185,000 in the adopted 2025/2026 Capital Works Budget to the Capital Development Grants Program. Capital development grants offer financial assistance to not-for-profit organisations to improve sport and active recreation infrastructure. Funding is provided as a one-off grant with the goal of benefiting sporting and recreation groups as well as the general community.

Fifteen applications were received in the 2025/26 funding round and eleven projects are recommended to be funded, totalling \$181,040 of Council grant contributions toward a combined project value of \$402,128.07. Funding agreements will be established with each recipient for the delivery of their initiative following formal consideration by Council.

Of the four applications not recommended to be funded, some related to works Council will already be delivering as part of its property and building maintenance services, while on others, Council will work with the unsuccessful applicants to support the outcomes being sought, including over following grant rounds.

DISCUSSION

Purpose and Background

The purpose of the Capital Development Grants is to support the local community to undertake Minor Capital Improvements to Council assets that benefit sport and recreation organisations and the wider community. A maximum of \$30,000 can be applied for with matching funding to be provided by the organisations.

The Grant applications proposed to be funded have demonstrated an ability to achieve significant outcomes in the four criteria outlined in the Capital Development Grant Program – Funding Guidelines, as follows:

- Clear evidence of demand for the project and the ongoing benefits to community participation (40%)
- The degree to which the organisation has provided the required project documentation and can demonstrate the ability to deliver the project

(30%)

- Demonstrated increased opportunities for female participation and/or disadvantaged groups (25%)
- Sustainability elements incorporated in design, materials, or outcomes (5%)

The 2025/26 guidelines prioritise projects that improve female participation, access for disadvantaged groups, and sustainability. Eligible projects include cosmetic upgrades to pavilions and club rooms, improvements to recreational facilities, new infrastructure promoting active lifestyles, safety enhancements, storage solutions, and fencing. Projects that involve maintenance responsibilities under existing leases, restrict public access, or include structural changes, operational costs, or non-permanent equipment are ineligible.

Options considered

In the adopted 2025/2026 Capital Works Budget, \$185,000 is allocated to the Capital Development Grants Program.

Recommended option and justification

The 2025/26 Recreation and Sport Capital Development Grant Program was assessed by an evaluation panel consisting of members from the Recreation & Sport, Facilities, Property and Minor Works team which recommends a total of\$181,040 be awarded to 11 applicants.

The total project value of each grant project is capped at \$80,000, with a maximum contribution of \$30,000 from Council.

The following process was followed by each of the assessors:

- 1. Applications assessed independently.
- 2. Allocated a project score using the criteria provided.
- 3. Met and discussed each project.
- 4. Agreed on a final score; and
- 5. Allocated funds based on the final outcomes of assessment and budget.
